#### 3. Best Practice:

### i) Local Authorities

Gary Woods shared Stockton BC process of producing end of term reports to summarise their scrutiny function. An infographic is produced to summarise the in-depth scrutiny reviews.

**Action** – It was requested that this infographic and a link to the report be shared with the officer network.

#### ii) CfGS

It was highlighted that some local authorities across the country are contravening the requirements of the Local Government Act 2000 by failing to have in place a dedicated Statutory Scrutiny Officer.

A discussion took place regarding the removal of the power to refer to the Secretary of State by the **Health and Care Act 2022**. The intention remains to remove it but it is not clear when or what will replace it.

- A request was made for any colleagues handling any service variations at the moment to get in touch with Helen Mitchell.

Round table events are taking place in October, the topics are finance and a closed session for governance professionals.

- CfGS requested that any case studies, blogs or examples of best practice be sent to Megan Ingle to be shared.
