NEPO525 – EXECUTIVE RECRUITMENT UPDATE

NEPO, in collaboration with Member Authorities have now concluded the procurement for the NEPO525 – Executive Recruitment Framework Agreement.

The Solution provides Member Authorities route to market for the sourcing and selection of executive level and senior leadership candidates into Permanent and Fixed Term roles. The Framework Agreement is also available to Contracting Authorities nationally.

The Framework is a single lot, multi-supplier solution for the provision of Executive Recruitment services with 8 Suppliers successfully awarded a place.

The Framework commenced June 7th 2022 for a period of 48 months with no further extensions and is now available for use.

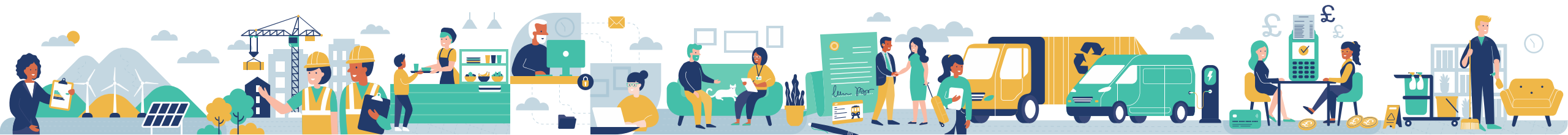

NEPO508 – AGENCY STAFF

- Commenced in November 2018 for a period of 60 months, inclusive of available extensions.
- Provides temporary staffing across a wide range of roles and specialities.
- Delivered by Geometric Results International (GRI) as a Neutral Vendor managed service.
- Approximately £50M of spend per annum by Member Authorities (2021/22)
- Renewal is now underway, with the new Framework Agreement scheduled to begin in November 2023.
- NEPO are currently engaged with Member Authorities to gather feedback on the existing Solution and future requirements to support future procurement activity.
